Commitment to Achieving Net Zero

Venture Health Group Ltd is committed to achieving **Net Zero emissions by 2050**, in line with UK Government policy and NHS net zero targets. As a healthcare services provider supporting the NHS, we recognise our responsibility to reduce emissions across all scopes and continually improve environmental sustainability in the way we deliver care.

Baseline Emissions Footprint

Our **baseline emissions year is 2023**, which reflects the first full year of business operations following our incorporation in December 2022. The baseline captures emissions related to travel, remote work, digital platforms, and subcontracted clinical activity.

Current Emissions Reporting

Emissions for the reporting year (2024 to date) are in line with our baseline, with marginal reductions due to more efficient travel planning and increased use of virtual clinical triage and consultation systems.

Emissions Reduction Targets

We are committed to reducing our emissions year-on-year and have adopted the following interim targets:

- **20% reduction in total emissions by 2030**
- **40% reduction by 2035**
- **Net Zero by 2050**

To meet these goals, we are implementing the following measures:

- Prioritising virtual consultation, MDTs, and pre-assessment clinics to reduce travel emissions
 - Implementing travel pooling or scheduling efficiency for essential clinical travel
 - Continuing to operate without leased vehicles or buildings, and working remotely wherever possible
 - Selecting cloud platforms hosted in energy-efficient UK data centres
 - Reviewing subcontractor sustainability practices and encouraging low-carbon travel methods
 - Publishing annual carbon reports and reviewing reduction progress each year

Carbon Reduction Projects

Since 2023, Venture Health Group Ltd has implemented the following initiatives:

- **Remote-first model:** All core staff operate remotely, reducing commuting and office energy emissions.
- **Digital-first operations:** We have developed web-based platforms to replace paper-based records and in-person meetings.
- **Sustainable subcontracting:** Where possible, we engage clinicians local to NHS sites to reduce travel emissions.
- **Green hosting:** Our web infrastructure is hosted with providers committed to renewable energy.

Further planned initiatives include:

- Implementing a staff carbon literacy training programme
 - Including sustainability considerations in subcontractor onboarding
 - Exploring the use of carbon offsetting for essential business travel (e.g. to NHS sites)
